Eligibility: The RMRJE is open to residents of Montana, Wyoming, North Dakota, Colorado, New Mexico, Utah and Idaho.

Entries: Oil, acrylic, watercolor, mixed media, drawings, and small 3-D sculpture are acceptable. No photographs, mixed media with photographs, prints, jewelry, or crafts are allowed. The Executive Director has final decision over the acceptance of non-traditional artwork into the jury process. All works must be original, made by the artist, and executed within the last 5 years. 2-D image size cannot exceed 2' x 3' (excluding frame). 3-D works cannot exceed 3'x3'x6' or weigh over 50 lbs. Artist may submit any number of pieces for jurying.

Entry Fee: Entry fee is not refundable. \$30 for first 3 entries; \$5 for each additional entry.

Awards: Cash prizes: 1st - \$500, 2nd - \$300, 3rd - \$200, 4th - \$100, People's Choice - \$50. 6 Honorable Mentions (no cash) will be given.

Submission Guidelines for the Jury Process: Images will be accepted for the jury process on CD or professional quality photograph (photos no larger than 5x7). No slides please. The original piece may not be submitted for the jury process. No frames or mats may be visible in photographs or on CD. Images on CD must be in jpg format. Custom slide shows with special effects on the CD are not acceptable. Images must be labeled with artist name, title and the corresponding entry number from the back of the entry form. Photos should be labeled on the back.

If submitted entries do not meet above guidelines, the artist will be asked to resubmit in proper format. Arts Guild staff will not manipulate received images to meet guidelines. The juror and staff reserve the right of refusal if the quality of the delivered work differs from the image submitted to the juror.

An appropriate size, self-addressed, envelope/padded mailer with sufficient postage must accompany all entries for the return of the CD/photographs. If no return envelope/padded mailer accompanies the entry, the CD/photographs will be destroyed at the end of the exhibit.

Accepted Artwork: Artists will be notified via telephone and in writing of the juror's results. Work accepted for the exhibit must be marked with: Artist Name, Title, Medium, Dimensions, and Date of Execution. Each entry must also be marked with #1, #2, #3, etc to correspond with the entry form. See important dates on the next page.



Liability: Artists are asked to carry their own insurance. The Depot premises are covered by KENCO Security and all reasonable precautions for safeguarding artwork will be taken. However, the Carbon County Arts Guild cannot assume responsibility for loss or damage incurred during transport, installation, display, or return of artwork.

Sales: All pieces must be for sale. The Arts Guild manages all sales and receives a 40% commission on the retail price.

Shipping: Upon notification of acceptance, work may be shipped or hand-delivered (see dates below). The artist is responsible for all delivery and return shipping costs, including insurance. For assistance with return shipping, contact the Arts Guild staff.

Juror/Judge: Shirley Barhaug, President of the Cody Country Art League, will choose artwork for the exhibit and will award the prizes.

About Shirley Barhaug: Shirley Barhaug was born and raised in Cody, Wyoming. Her love of art and fellow artists has always enriched her life. She started utilizing her talent over 40 years ago. Everyone in the Barhaug family is artistic and everyday seems to offer a new challenge. Shirley feels very blessed to be a member of the Buffalo Bill Art Show Committee. She has been President of the Cody Country Art League for 18 years. It has been, and continues to be, an adventure teaching watercolors and free handed florals and this venue has let her meet so many very special people.
